

RULES OF ORDER FOR ROPPESTAD

Roppestad is a state-secured outdoor recreation area and can be used by the public according to the following guidelines:

1. Anyone using the site must follow the instructions given on notices or directly by the supervisor. It is a requirement that everyone observes general order, cleanliness and decent behaviour. Intoxicated persons may be shown away from the area.
2. Consideration must be given to the part of the property that has been cultivated, so that plants and crops are not trampled or damaged in any other way.
3. Associations and other collaboration units that wish to use the free area for meetings, conventions etc., must obtain permission in advance from Larvik municipality.
4. Everyone who uses Roppestad is obliged to clean up after themselves. Waste is placed in a container when it is deployed, otherwise waste is taken with you when you leave the site.
5. The outdoor area is permitted to be used for overnight stays with tents. Caravans/motorhomes are placed according to further instructions. Based on the fire regulations, **a safety distance of at least 4 meters** must be observed between each housing unit. **Accommodation can only take place for up to 2 days at a time in parts of the area, and only as far as capacity allows.** For camps/conventions, Larvik municipality can in special cases grant a dispensation from the time limit. Only tents are allowed in the area at the southern tip, which is blocked off with a chain link. Vehicles/campervans/motorhomes are not permitted in this area without written permission from Larvik municipality. The boom must be locked.
6. Use of radio/stereo systems and the like must not occur in such a way that the surroundings are disturbed.
7. Open fires/bonfires outside approved fireplaces are not permitted (Fire Regulations). On special occasions, in consultation with the fire chief, permission may be granted for this, but only in a designated, safe place. "Fire barrels" are strictly prohibited, such must not be left around the property
8. It is permitted to swim in Farrisvannet from the free area, but pollution must be avoided. Bathing buoys in the water must not be touched by bathers.
9. Parking of cars is only permitted in designated places (see signage). Driving a car/motorcycle in the area must be done with consideration and following the roads. Driving a car/motorcycle in other places: only according to the authority's instructions.
10. The toilets are for everyone, people must be allowed to go to the toilet in peace. Therefore, there must be a minimum 10 meter free zone around the entire toilet building. Do not empty Porta-Potti etc. in the toilets, trampling results in expulsion / police report.
11. On normal working days, calm should prevail at 11:00 p.m. On Saturdays and other days with special events at 00:00.

12. In the period 1 May to 15 September, there is a security guard at Roppestad, who will supervise that the rules of order are observed. The security guard is appointed by Larvik municipality and has the right and duty to expel anyone who violates the rules of order or who does not follow the security guard's instructions. If guests do not comply with the supervisor's advice, photographic evidence of the violations that occur can be taken, as well as information about the parties involved. This is passed on to Larvik municipality, which manages the property. If the supervisor believes that the situation will be too difficult to sort out, they have Larvik municipality's authority to call the police.
